

Cookie Policy

This Cookie Policy explains which technologies Microblink uses to collect information and improve user experience. Provisions of this Cookie Policy apply to Microblink LLC (Trg Drage Iblera 10, 10000, Zagreb), and its affiliated companies Microblink Ltd. (6th Floor, 9 Appold Street, London, United Kingdom, EC2A 2AP), BlinkReceipt, LLC (d/b/a Microblink) (10 Grand St, Suite 2400, Brooklyn, NY 11249, United States of America) and SourcePad INT'L, INC. (25 ADB Avenue, Suite 2701 Discovery Centre Building, Ortigas Center, Pasig City), jointly referred to as "Microblink". 1. What is a cookie

A "cookie" is a small data file transferred by a website to your device's hard drive. The cookies are set when you access Microblink websites. Some cookies are set by Microblink (first-party cookies) and Microblink also uses cookies from domains different than Microblink's for the purpose of advertising and marketing efforts (third-party cookies). Cookies help Microblink and Microblink service providers to remember information about your use of our website and/or services, such as your language preference or login information. Therefore, by accepting the cookies that we use, you give us access to such information which we use to optimize our services for you and personalize your experience based on your preferences.

2. Types of cookies used on our website

Microblink website is regularly scanned with our cookie scanning tool in order to maintain an accurate list of cookies. We classify cookies in the different categories according to their purpose. You can see the list of active cookies in the Cookie Settings.

Cookie Settings

These cookies are necessary for the website to function and cannot be switched off in our systems. They are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms. You can set your browser to block or alert you about these cookies, but some parts of the site will not then work. These cookies do not store any personally identifiable information.

3. How long the cookies persist in your browser

The length of time a cookie will stay on your device depends on whether it is a "persistent" or "session" cookie. Session cookies will only stay on your device until you stop browsing. Persistent cookies stay on your device until they expire or are deleted.

Please note that data provided through cookies is not shared with anyone except the cookie providers.

4. Web beacons

A web beacon is an electronic image, called a single-pixel (1x1) or clear GIF. Web beacons can recognize certain types of information on your devices such as cookies, the time and date of a page viewed, and a description of the page where the web beacon is placed. Depending on the context, web beacons may also refer to content on a third-party server and may be used by service providers to

deliver relevant advertising to you.

5. How to manage cookies

By clicking “Accept all cookies” on our cookie banner, you consent to the use of cookies and you accept all types of cookies we use, as outlined above in Types of cookies used on our website.

You can manage cookies by changing the settings by clicking on Cookie Settings button or within your browser.

If you click Cookie Settings displayed in the cookie banner when you first visit our website or click the Cookie Settings button available in this Cookie policy, you can access the Preference Centre. It allows you to view the types of cookies we store (as outlined above in Types of cookies used), and opt-out each cookie type, except Strictly necessary cookies.

If you wish to refuse all cookies, you can block them by managing your options in your browsers tool settings. Additionally, by clearing your browsing history of your browser, you can delete cookies that have already been stored on your device. This will remove all cookies settings from all websites you have visited. If you have blocked or deleted all or some cookies, it is possible that the website will no longer function correctly or that you will not have access to some features on the website, for which we cannot be held liable.
